PEJ: no modifications were requested by Judges upon dissemination of the final draft of the minutes.

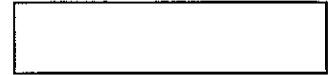
The Assembly unanimously approves.

2) APPROVAL OF THE PROPOSAL THAT ALL ANNEXES TO THE GUIDELINES ON CASE SELECTION AND CASE ALLOCATION AT SUPREME COURT LEVEL ON CRIMINAL CASES WILL BE UPDATED BY OPEJ BASED ON THE TURNOVER OF EULEX JUDGES AS LIKE AS KOSOVO SUPREME COURT JUDGES DEPENDING ON THE NOTIFICATIONS OF SUPREME COURT PRESIDENT FEJZULLAH HASANI (REPORTING FOCAL POINT JUDGE MARTTI HARSIA).

The Assembly approves with 1 abstention, 28 in favor, none against.
