



Adoption of Decision on the Election Procedure in the Assembly (1)



1. This decision applies to the election of the members for the Selection Panel of the President of the Assembly of EULEX Judges and the Vice-President of the Assembly of EULEX Judges, for the Selection Panels for Criminal Judges, for the Selection Panels for Civil Judges, SCSC Judges and KPA Appeal Panel Judges, for the Disciplinary Board and for the Evaluation Panels.
2. A Judge may present his/her candidacy for the above-mentioned panels by
 - a. sending an E-mail to OPEJ and EULEX Judges before the meeting of the Assembly; or
 - b. addressing the Assembly directly.
3. In case a Judge presents his/her candidacy according to 2 a, he/she may be elected *in absentia*.
4. Before the ballot, the candidates present at the Assembly shall briefly introduce themselves.
5. Where both members and substitutes for one panel/board are elected, it shall not be possible to present a candidacy for substitute only. Candidacy for membership shall imply candidacy for substitute.
