## **CONTRACT SPECIFICATIONS**

#### **6. Description of the contract**

The subject of the contract is the supply, delivery and installation by the Contractor of “Firearms Simulators”, along with the performance of some ancillary services such as training and maintenance (see annex II + III of the Tender Dossier for the detailed specifications of the items and ancillary services) in one (1) lot at EULEX Kosovo, Pristina, DDU<sup>1</sup>. The delivery period i.e. 80 (eighty) days for items 1 and 2 and 160 (one hundred and sixty days) days for item 3, shall run from the date of signature of the contract by both parties.

#### **7. Number and titles of lots**

This tender procedure is not divided into lots.

## TERMS OF PARTICIPATION

### 8. Eligibility and rules of origin

Participation in tendering is open to all legal persons participating either individually or in a grouping (consortium) of tenderers which are established in a Member State of the European Union, in an official candidate country, or a country that is a beneficiary of the Instrument for Pre-Accession Assistance, in a Member State of the European Economic Area, a country of the Western Balkans region or a contributing third State, as authorized by Council Joint Action 2008/124/CFSP of 04 February 2008 on EULEX KOSOVO, (see item 22 below). Participation is also open to international organizations. Participation of natural persons is directly governed by the specific instruments applicable to the programme under which the contract is financed.

The rule of origin has been derogated.

### 9. Grounds for exclusion

Tenderers must submit a signed declaration, included in the Tender Form for a Supply Contract, to the effect that they are not in any of the situations listed in point 2.3.3 of the *Practical Guide to contracts procedures for EC external actions*.

### 10. Number of tenders

Tenderers may submit only one tender per lot. Tenders for parts of a lot will not be considered. Any tenderer may state in its tender that it would offer a discount in the event that its tender is accepted. Tenderers may not submit a tender for a variant solution in addition to their tender for the supplies required in the tender dossier.

### 11. Tender guarantee

Tenderers must provide a tender guarantee **of an amount of 7,000.00 EUR (seven thousand Euros)** when submitting their tender. This guarantee will be released to unsuccessful tenderers once the tender procedure has been completed and to the successful tenderer(s) upon signature of the contract by all parties. This guarantee will be called upon if the tenderer does not fulfil all obligations stated in its tender.

### 12. Performance guarantee

The successful tenderer will be asked to provide a performance guarantee **of 8 %**, of the amount of the contract at the signing of the contract. This guarantee must be provided together with the return of the countersigned contract no later than 30 days after the tenderer receives the contract signed by the Contracting Authority. If the selected tenderer fails to provide such a guarantee within this period, the contract will be void and a new contract may be drawn up and sent to the tenderer which has submitted the next cheapest compliant tender.

### 13. Information meeting and/or site visit

No information meeting is planned.

#### **14. Tender validity**

Tenders must remain valid for a period of 90 days after the deadline for submission of tenders.

#### **15. Period of implementation**

Deliveries shall take place within 80 (eighty) days for items 1 and 2 and 160 (one hundred and sixty days) days for item 3, after the signature of the contract by both parties.

### **SELECTION AND AWARD CRITERIA**

#### **16. Selection criteria**

The following selection criteria will be applied to tenderers. In the case of tenders submitted by a consortium, these selection criteria will be applied to the consortium as a whole:

- 1) Economic and financial capacity** of tenderer (based on i.a. item 3 of the Tender Form for a Supply Contract). In case of tenderer being a public body, equivalent information should be provided.
  - a) The average turnover of the tenderer for the years 2009 and 2008 must exceed twice the amount of its financial proposal.
- 2) Professional capacity** of tenderer (based on i.a. items 4 and 5 of the Tender Form for a Supply Contract)
  - a) At least two qualified instructors, (trainers), English speakers, currently work for the tenderer.
  - b) The tenderer must demonstrate having at its disposal a dedicated telephone hotline in English language or a remote internet support in English language.
- 3) Technical capacity** of tenderer (based on i.a. items 5 and 6 of the Tender Form for a Supply Contract)
  - a) All together, the tenderer has worked successfully on at least five (5) projects of supply and installation of Interactive Firearm Simulator within the last three years (2009,2008,2007). These projects must have been accomplished for Law Enforcement Agencies.

An economic operator may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links which it has with them. It must in that case prove to the Contracting Authority that it will have at its disposal the resources necessary for performance of the contract, for example by producing an undertaking on the part of those entities to place those resources at its disposal. Such entities must respect the same rules of eligibility and notably that of nationality, as the economic operator.
