CONTRACT SPECIFICATIONS

6. Description of the contract

The subject of the contract is the supply, delivery (and for the RHIB, commissioning in-situ, see lot 1) by the Contractor of the following goods (see Annex II and III of the Tender Dossier for the relevant description and quantities per item) in 3 (three) lots at EULEX Kosovo, Pristina, DDU¹.

7. Number and titles of lots

Lot 1	RHIB (Rigid Hull Inflatable Boat)
Lot 2	Dry Suits and Underclothing
Lot 3	RHIB Associated Items

The deliveries shall take place within 60 (sixty) calendar days after the receipt by the contractor of an “administrative order”.

TERMS OF PARTICIPATION

8. Eligibility and rules of origin

Participation in tendering is open to all legal persons participating either individually or in a grouping (consortium) of tenderers which are established in a Member State of the European Union, in an official candidate country, or a country that is a beneficiary of the Instrument for Pre-Accession Assistance, in a Member State of the European Economic Area, a country of the Western Balkans region or a contributing third State, as authorized by Council Joint Action 2008/124/CFSP of 04 February 2008 on EULEX KOSOVO, (see item 22 below). Participation is also open to international organizations. Participation of natural persons is directly governed by the specific instruments applicable to the programme under which the contract is financed

The rule of origin has been derogated.

9. Grounds for exclusion

Tenderers must submit a signed declaration, included in the Tender Form for a Supply Contract, to the effect that they are not in any of the situations listed in point 2.3.3 of the *Practical Guide to contracts procedures for EC external actions*.

10. Number of tenders

Tenderers may submit only one (1) tender per lot. Tenders for parts of a lot will not be considered. Any tenderer may state in its tender that it would offer a discount in the event that its tender is accepted for more than one lot. Tenderers may not submit a tender for a variant solution in addition to their tender for the supplies required in the tender dossier.

11. Tender guarantee

Tenderers must provide a tender guarantee of **470 Euros for LOT 1 (four hundred and seventy Euros)** (no tender guarantee is required for LOT 2 and 3) when submitting their tender. This guarantee will be released to unsuccessful tenderers once the tender procedure has been completed and to the successful tenderer(s) upon signature of the contract by all parties. This guarantee will be called upon if the tenderer does not fulfil all obligations stated in its tender.

12. Performance guarantee

The successful tenderer will be asked to provide a performance guarantee of **10 %** of the amount of the contract at the signing of the contract. This guarantee must be provided together with the return of the countersigned contract no later than 30 days after the tenderer receives the contract signed by the Contracting Authority. If the selected tenderer fails to provide such a guarantee within this period, the contract will be void and a new contract may be drawn up and sent to the tenderer which has submitted the next cheapest compliant tender.

13. Information meeting and/or site visit

No information meeting is planned

Tender validity

Tenders must remain valid for a period of 90 days after the deadline for submission of tenders.

14. Period of implementation

The contract will enter into force on the date of its signature by both parties, but it will be only be implemented by means of an “administrative order” i.e. deliveries shall only take place following the issuance by the contracting authority of an “administrative order”. Deliveries shall take place within 60 (sixty) calendar days after the receipt by the contractor of an “administrative order” issued by the Contracting Authority.

The Contracting Authority will issue the “administrative order” within 90 calendar days from the date of contract signature.

SELECTION AND AWARD CRITERIA

15. Selection criteria

The following selection criteria will be applied to tenderers. In the case of tenders submitted by a consortium, these selection criteria will be applied to the consortium as a whole:

- 1) Economic and financial capacity** of tenderer (based on i.a. item 3 of the Tender Form for a Supply Contract). In case of tenderer being a public body, equivalent information should be provided.
 - a) The average turnover of the tenderer must exceed the amount of its financial proposal for the lot(s) tendered. (i.e. the aggregated value if several lots are tendered).
- 2) Professional capacity** of tenderer (based on i.a. items 4 and 5 of the Tender Form for a Supply Contract)
 - a) For lot 1 the tenderer shall have a manufacturer’s authorization form.
 - b) At least two (2) staff currently work for the tenderer in fields related to this contract.
- 3) Technical capacity** of tenderer (based on i.a. items 5 and 6 of the Tender Form for a Supply Contract)
 - (a) FOR LOT 1, the tenderer has worked successfully on at least three projects directly related to the supply of Rigid Hull Inflatable Boats, in the past three years 2007, 2008 and 2009.
 - (b) FOR LOTS 2 and 3, the tenderer has worked successfully on at least three projects, in fields related to the subject of these lots in the past three years i.e. 2007, 2008, 2009.

An economic operator may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links which it has with them. It must in that case prove to the Contracting Authority that it will have at its disposal the resources necessary for performance of the contract, for example by producing an undertaking on the part of those entities to place those resources at its disposal. Such entities must respect the same rules of eligibility and notably that of nationality, as the economic operator.
