**CORRIGENDUM NO. 1**

**A) The following corrections are made to Volume 4: Financial Offer Unit Price Contracts**

**Tenderers are accordingly required to use the final Bill of Quantity with reference “Annex 2 volume 4 Modified Bill of Quantities”**

*The initial Bill of Quantity was deleted from the EULEX website and should be ignored by the tenderers.*

Here is a summary of the changes that were introduced:

- **Construction of Office Block 1**

Item 1.1 - Placement of 20' (604cmx244cm) office containers over the existing concrete strip foundation on site, as per the dwg/layout provided (A-02). Assembled office containers will be provided by EULEX and are located within the site. Setup of office containers is to be modified as per floor plans provided for office block 1, removing/relocating the panels as required creating double triple containers office – **IS DELETED**;

Item 1.2 - Placement of 20' (604cmx244cm) Ablution Unit over the existing concrete strip foundation on site, as per dwg/layout provided (A-02). Ablution Units are to be provided by EULEX, and are located within the site – **IS DELETED**;

- **Construction of Office Block 2**

Item 1.1 - Placement of 20' (20 feet - 604cmx244cm) office containers over the existing concrete strip foundation on site, as per the dwg/layout provided (dwg A-02). Assembled office containers will be provided by EULEX and are located within the site. Setup of office containers is to be modified as per floor plans provided for office block 1, removing/relocating the panels as required creating double triple containers office – **IS DELETED**;

Item 1.2 - Placement of 20' (20 feet - 604cmx244cm) Ablution Unit over the existing concrete strip foundation on site, as per dwg/layout provided (dwg A-02). Ablution Units are to be provided by EULEX, and are located within the site. – **IS DELETED**;
