## **MISSING PERSONS**



EULEX forensic experts work with local counterparts at the Institute of Forensic Medicine and other relevant Kosovo institutions to determine the fate of missing persons by offering expertise and advice, in order for family members to realize their right to know the truth.

## From the inception of EULEX's mandate to 14 June 2025

EULEX has actively participated in **873 field operations** to locate missing persons, including **219 exhumations**. The remains of **543 individuals have been identified**, including **370 missing persons**.

# EULEX continues to manage its own witness protection programme.



The Mission assists the Kosovo Specialist Chambers and Specialist Prosecutor's Office with logistic and operational support in line with relevant Kosovo legislation.

# European Union Rule of Law Mission in Kosovo Partnership for justice





### **WHO WE ARE**

The European Union Rule of Law Mission in Kosovo (EULEX Kosovo) was launched in 2008 as the largest civilian mission under the Common Security and Defence Policy of the European Union. Its mission is to support selected Kosovo rule of law institutions on their path towards increased effectiveness, sustainability, multi-ethnicity and accountability, free from political interference and in full compliance with international human rights standards and best European practices.

### WHAT WE DO

EULEX assesses the adherence of selected Kosovo institutions to the rule of law and human rights obligations, with a clear commitment against any form of human rights abuse or discrimination.

EULEX implements its mandate through the Monitoring Pillar and the Operations Support Pillar. The Mission is dedicated to the inclusion of human rights and gendermainstreaming standards in all its activities.



## **MONITORING PILLAR**



EULEX assesses the functioning of the Kosovo judiciary in terms of procedural, legal and human rights compliance through monitoring of selected cases at the entire chain of the criminal justice system, i.e. on police, prosecutorial and judicial level.

From June 2018 to 14 June 2025, EULEX's justice monitors attended:



including high-profile cases, war crimes cases, gender-based violence cases, corruption cases, and cases previously dealt with by EULEX. This monitoring results in reports with findings and recommendations for the Kosovo authorities aimed at improving the justice system.

Through monitoring, mentoring and advising, the EULEX Correctional Unit supports the Kosovo Correctional Service (KCS) in consolidating a professional management team and helping build up capacities in providing rehabilitation, and countering undue interference and preferential treatment of prisoners. EULEX also assists the Kosovo Probation Service (KPS) to develop a structured approach to probationers' rehabilitation focusing on prevention of re-offending

# From June 2018 to 14 June 2025 EULEX's Correctional Unit staff:

- Conducted over 1150 field visits to various correctional facilities and to the regional probation offices and had hundreds of meetings with KCS and KPS staff to support the management in addressing strategic issues.
- Monitored 109 hospital escorts of high-profile prisoners.
- Supported training sessions, workshops and working groups for over 2,600 participants.

## **OPERATIONS SUPPORT PILLAR**





EULEX is Kosovo's second security responder, as part of a threetiered security responder mechanism. The EULEX's Formed Police Unit (FPU) can only engage at the explicit request of the first security responder in order to contribute to the maintenance and promotion of public order and security in cases of civil disturbance.

The FPU carries out mobile reconnaissance patrols to gain situational awareness and continuously engages in joint crowd-and-riot control exercises with the Kosovo Police and KFOR.

### **INTERNATIONAL POLICE COOPERATION**

EULEX facilitates the exchange of police information between the Kosovo Police and Interpol, Europol or the Serbian Ministry of Interior.
