2	Lot 2	Software Licenses  Position 2.8”Print Server Replacement Software” There is required quantity of 1 license “For 495 devices”. However in ANNEX IV: Budget break down (Model financial offer)-it is required quantity 400 pcs. Could you please clarify the correct quantity of the licenses and the supporting devices of the “Print Server Replacement Software”	This requirement is for a Print Server Replacement Software (or license) that will cover 495 devices.
